## § 17.01 Legal Books.

A. South Carolina Workers' Compensation Law Annotated.

This is a must for every claimant's lawyer's library. Updated yearly by the West Group, it contains Title 42 of the code with case annotations, as well as the Workers' Compensation Commission Regulations. Most lawyers carry this with them to hearings.

B. Larson's Workers' Compensation Law.

Larson's is the treatise on workers' compensation law.
